## Maserculiq, Incorporated

### Philanthropy Policy

The Maserculiq, Incorporated Board of Directors believes that the corporation has a responsibility to contribute to and help support the communities in which the Corporation and its shareholders reside and do business. The Corporation Philanthropy Policy aims to provide support to those communities by making donations in those instances it deems appropriate to government and quasi-government organizations and to public service organizations and associations. The object of Philanthropic assistance from Maserculiq is not to support or assist individuals or families, but rather to provide support to entities that provide broad benefit to a community. Maserculiq recognizes that the Corporation is not a social service agency, and that such a role is properly reserved for tribal entities or other social service agencies.

The board also recognizes its ultimate responsibility of serving as steward of corporate assets which ultimately belong to the owners of the corporation, our shareholders.

Any governmental or quasi-governmental organization or public service organization or association must follow the steps below to solicit a contribution from the corporation:

1. Submit an application at least thirty days and a maximum of 90 days prior to the need, using the Maserculiq, Incorporated Application for Corporate Donation form included in this policy statement or organization letterhead.
2. The application must include information on the reason for the organization seeking the donation, how the donation will provide broad benefit to a community, what community will benefit, and what other sources have been approached for funding.

The Board of Directors shall evaluate applications based on the following criteria: Is the community that will be benefited if the grant is made one where a significant number of Corporation shareholders reside or where the Corporation conducts business? Will the grant provide broad community benefits? Is the application complete? Did the applicant look for other funding sources prior to the submission of the application?

Please note that Maserculiq, Incorporated Philanthropy Grants will not be made to individuals or families, or to organizations that primarily benefit of a small number of individuals.

The decision to approve or decline an Application for Corporation Donation is ultimately left to the discretion of the Board of Directors. The decision of the Maserculiq, Incorporated Board of Directors on a Philanthropy Application is final. Funds for Philanthropy purposes are limited. Not all Philanthropy Applications can or will be funded.

To avoid any appearance of impropriety, no sitting board member may submit a philanthropy application to the Board. No sitting board member may advocate in favor of a philanthropy application which would benefit themselves, a member of their immediate family, or an organization to which they may belong. No sitting board member may vote on a philanthropy application which would benefit themselves, a member of their immediate family, or an organization to which they may belong.
